The National Bank of Moldova (NBM) aims to strengthen its institutional capacities in the mentioned field, to ensure a continuous development of banking supervision in order to respond to the challenges of the external environment and prevent situations of vulnerability in the banking sector.

"After the approval of a robust regulatory and supervisory framework for banks, starting with 2018, the NBM has been making increased efforts to ensure its efficient and uniform implementation. As all reforms imply the involvement of human resources, the structure of the Banking Supervision Department has been developed by restructuring processes, defining responsibilities more clearly, and streamlining reporting lines", says Constantin Şchendra, the NBM Deputy Governor, who is responsible for this field within the central bank.

Thus, the NBM encourages the community of specialists with experience in the economic field, interested in professional development, but also willing to come with a personal contribution in ensuring the stability of the banking sector to apply for participation in job competitions announced on its [official website](#) [1], as well as on relevant [social media pages](#) [3].

Diversity is encouraged within the NBM, therefore, people without work experience, but with high economic education and great professional interest, can apply for vacancies that do not have specific experience requirements.

To get closer to those interested, the National Bank of Moldova organizes an online event on 12 April 2022, starting with 10.00 AM, where participants will discover the field of banking supervision within the NBM, having a direct dialogue with the representatives of the central bank.
