According to preliminary data, in Quarter II, 2023, the **current account** of the balance of payments recorded a deficit of US\$ 409,69 million, a 12,1% decrease as compared to the similar period of the previous year. The current account to GDP ratio amounted to -10,5%.

The **capital account** recorded a positive balance amounting to US\$ 11,65 million, and the **financial account** recorded a net inflow of US\$ 413,92 million.
