According to preliminary data, in Quarter II, 2021, the current account of the balance of payments recorded a deficit of US\$ 506,52 million, the capital account registered a negative balance amounting to US\$ 17,96 million, and the financial account recorded a net capital inflow of US\$ 486,07 million. The international investment position amounted to US\$ -5 643,91million as of 06/30/2021, while the gross external debt totaled US\$ 8 504,91 million.
