Pursuant to Article 11 and Article 27, paragraph 1, letter c) of the Law No 548/1995 on the National Bank of Moldova (republished in the Official Monitor of the Republic of Moldova, 2015, No 297-300, Article 544), with further amendments, Article 37, paragraph 1) of the Law No 202/2017 on the activity of banks (Official Monitor of the Republic of Moldova, 2017, No 434-439, Article 727), with further amendments, the Executive Board of the National Bank of Moldova

#### **DECIDED:**
