## Developments in loan and deposit markets in May 2020

In May 2020, new loans<sup>1</sup> extended by banks totalled MDL 2,012.1 million, a decrease of 25.9%, compared to May 2019.

The share of loans issued in domestic currency totalled 72.0%, in foreign currency – 25.1%, while foreign-currency-linked<sup>2</sup> – 2.9% (Chart 1, upper chart).

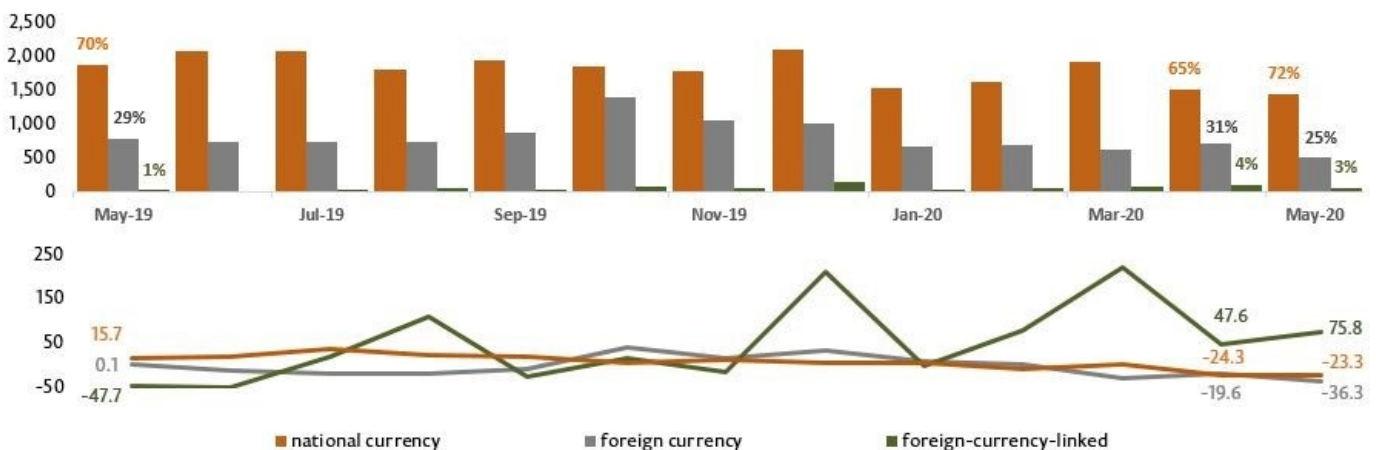
The amount of loans issued in domestic currency constituted MDL 1,448.0 million (-4.5% compared to the previous month and -23.3% compared to May 2019 (Chart 1, lower chart)).

The amount of loans issued in foreign currency recalculated in MDL, totalled MDL 505.4 million (-29.1% compared to the previous month and -36.3% compared to May 2019 (Chart 1, lower chart)).

The amount of foreign-currency-linked loans constituted MDL 58.7 million (-43.2% compared to the previous month and +75.8% compared to May 2019) (Chart 1, lower chart)).

**Dynamics of new loans, million MDL (upper chart) and the annual growth rate of new loans extended by banks, % (lower chart)**

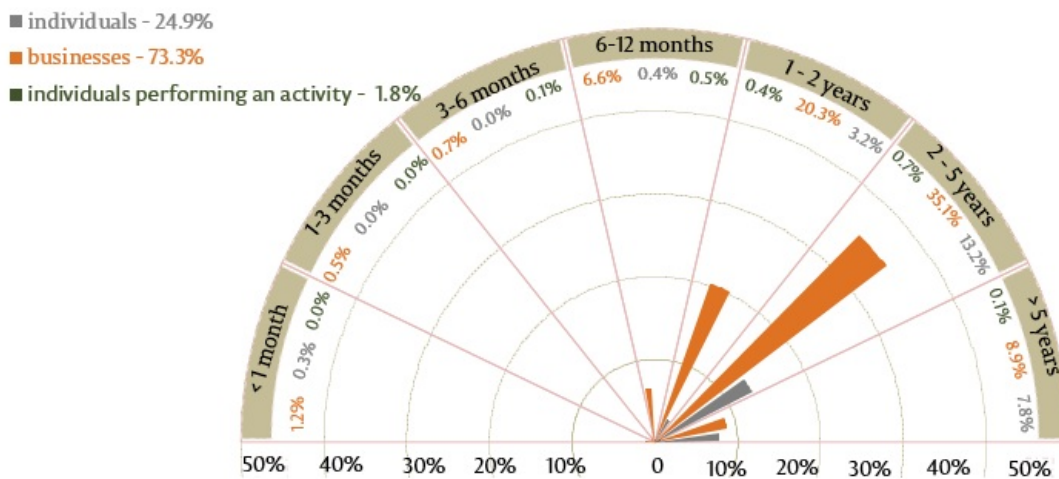

It should be mentioned that, in terms of maturity, loans with maturity ranging from 2 to 5 years recorded the highest demand (49.1% of total loans extended), out of which the largest share of 35.1% of the total loans was held by businesses (Chart 2).

**New loans extended by maturity and their shares, %**



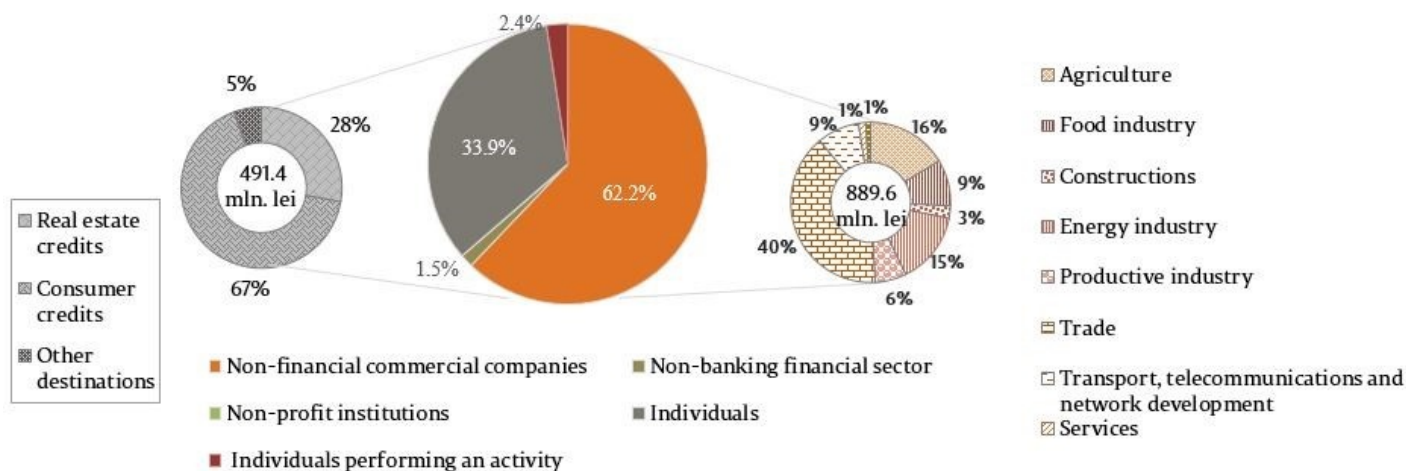

Domestic currency loans were mainly represented by loans extended to legal entities (63.6%), including loans extended to non-financial commercial companies holding a share of 62.2% (39.9% belong to trade) (Chart 3).

**Foreign currency loans were mainly requested by non-financial commercial companies (94.0%), and the largest share (44.0%) belongs to trade.**

**Domestic currency loans by business sectors, %**

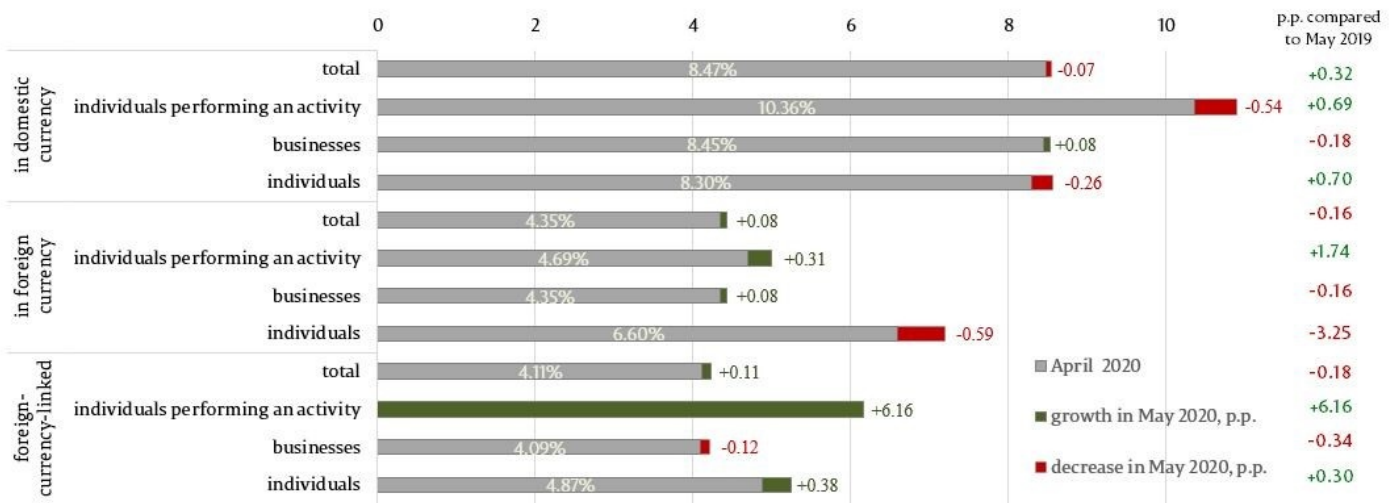

**New loans in domestic currency were extended at an average interest rate of 8.40%, the loans in foreign currency – 4.43% and foreign-currency-linked – 4.22%.**

Average interest rate of domestic currency loans decreased by 0.07 percentage points compared to the previous month. Individuals received loans at an average interest rate of 8.04%, legal entities – at a rate of 8.53%, while individuals performing an activity<sup>3</sup> – at a rate of 9.82% (Chart 4).

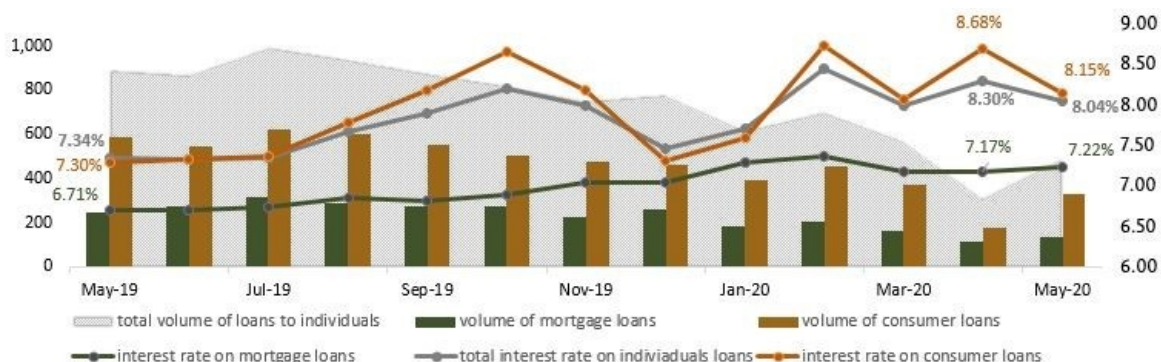
Average interest rate of foreign currency loans increased by 0.08 percentage points compared to April 2020. Individuals received loans at an average interest rate of 6.01%, businesses – at a rate of 4.43%, while individuals performing an activity – at a rate of 5.00%.

Average interest rate of foreign-currency-linked loans increased by 0.11 percentage points, compared to April 2020. Individuals received loans at an average interest rate of 5.25%, legal entities – at a rate of 3.97%, and individuals performing an activity – at a rate of 6.16%.

Compared to the similar period of the previous year, the interest rates of domestic currency loans increased by 0.32 percentage points, of foreign currency and foreign-currency-linked loans decreased by 0.16, and by 0.18 percentage points, respectively.

The volume (million MDL) and the average interest rates of loans issued to individuals, in domestic currency (%)



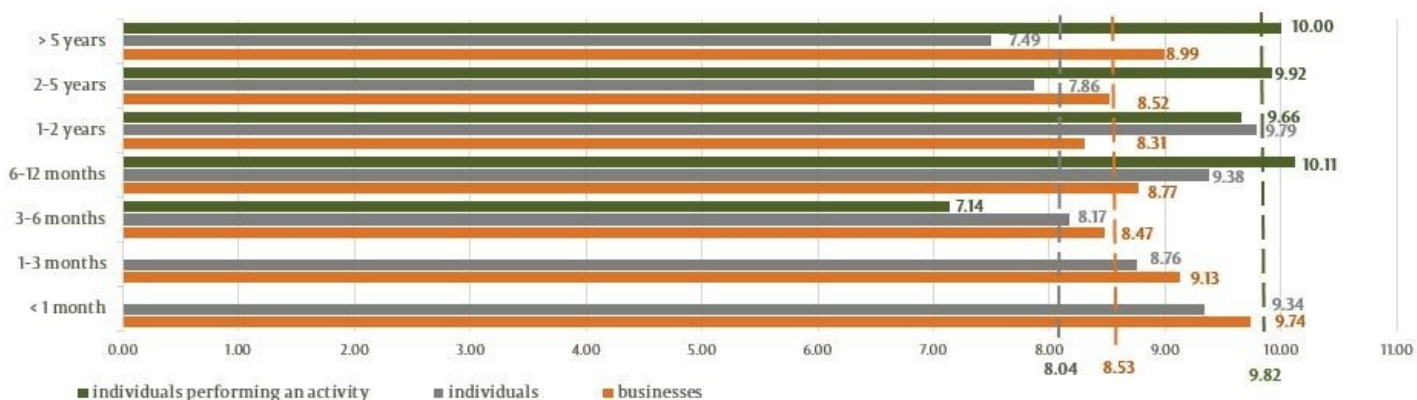

The volume of loans in domestic currency issued to individuals in May 2020 increased in comparison with the previous month by 56.0% and totalled MDL 491.4 million (Chart 5). The average rate of loans in domestic currency issued to individuals in the same period decreased by 0.26 percentage points and constituted 8.04%. From the perspective of scope of issued loans, the consumer loans had the highest share (66.7%). In comparison with the previous reference month, the rate of consumer loans decreased by 0.53 percentage points, while the rate of mortgage loans increased by 0.05 percentage points. Compared to the previous year, the rate of consumer loans increased by 0.85 percentage points, while of mortgage

loans - by 0.51 percentage points. It should be mentioned that the share of mortgage loans issued in domestic currency constituted 94.9% (5.1% refer to the foreign-currency-linked loans), while consumer loans – 99.7% (0.2% were issued as foreign-currency-linked).

**Average interest rates of domestic currency loans, by maturity, %**



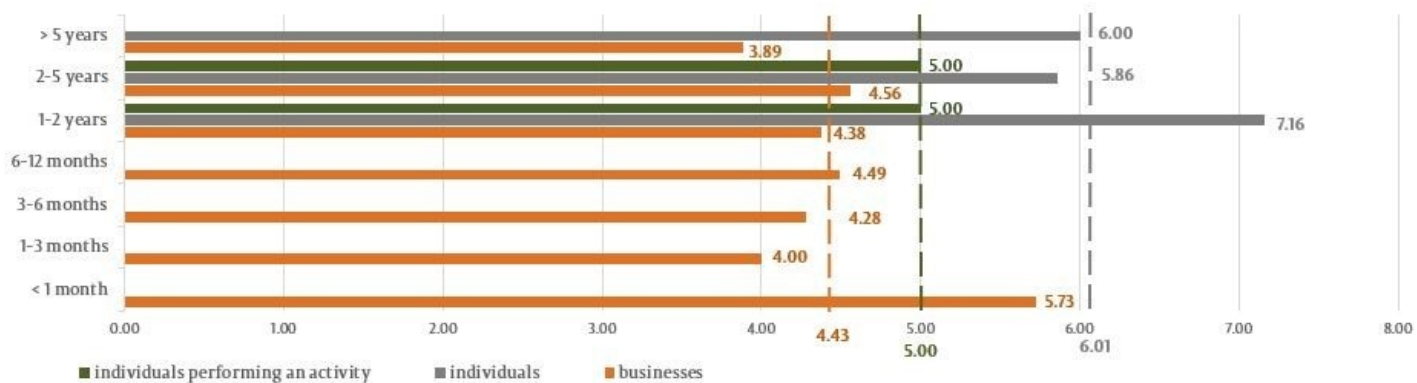

Domestic currency loans with maturity from 2 to 5 years recorded the highest demand in the reporting month and were extended at an average interest rate of 8.28% (8.52% - for legal entities, 7.86% - for individuals, and 9.92% for individuals performing an activity), (Chart 6).

It should be mentioned that the highest average interest rate of extended domestic currency loans was registered for loans with maturity up to 1 month, and constituted 9.65% (9.74% - for legal entities, 9.34% - for individuals). Individuals performing an activity did not apply for loans foreign-currency-linked up to 1 month (Chart 6).

**Average interest rates of foreign currency loans, by maturity, %**

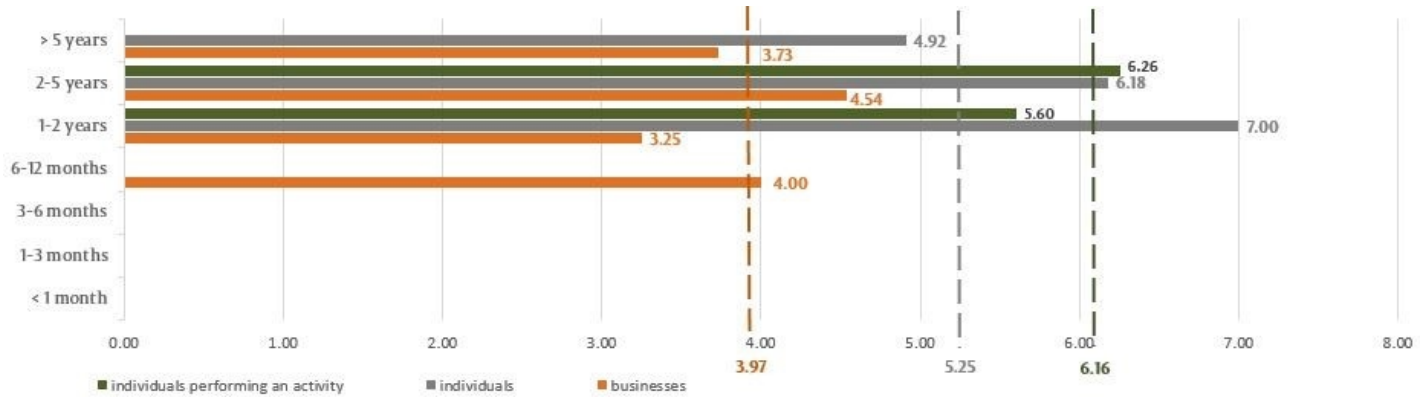

The most attractive foreign currency loans with maturity from 2 to 5 years were extended at an average interest rate of 4.57%, where individuals were granted loans with an average interest rate of 5.86%, legal entities – with an average rate of 4.56%, while individuals performing an activity – with an average rate of 5.00% (Chart 7).

**Average interest rates of loans foreign-currency-linked by maturity, %**



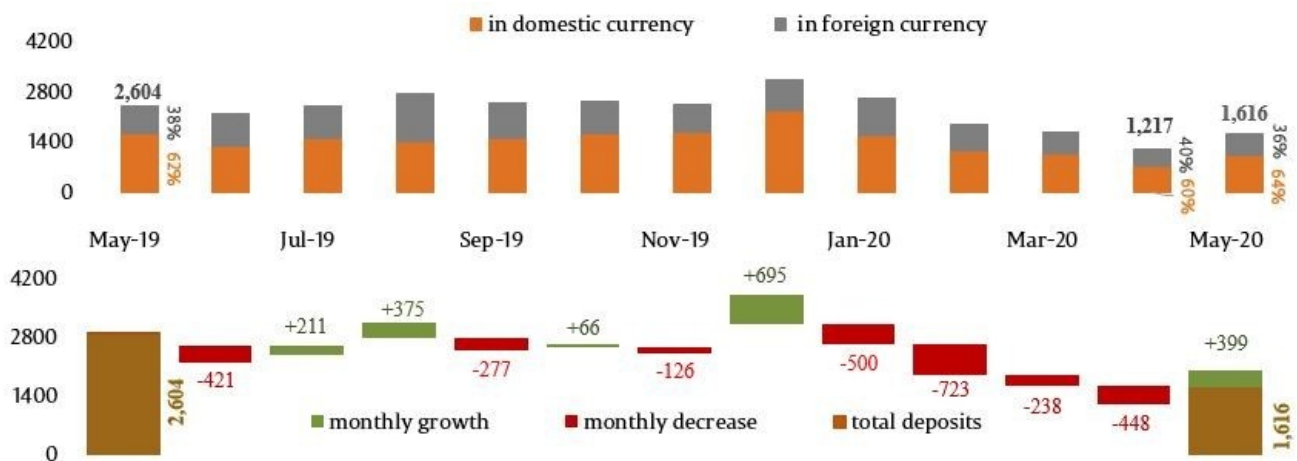

The most attractive loans foreign-currency-linked, with maturities over 5 years, have been issued at an average interest rate of 3.93%, individuals received loans at an average interest rate of 4.92%, while legal entities – at an average rate of 3.73%, (Chart 8).

In May 2020, the new term deposits totalled MDL 1,616.4 million, decreasing by 37.9% compared to May 2019 (Chart 9).

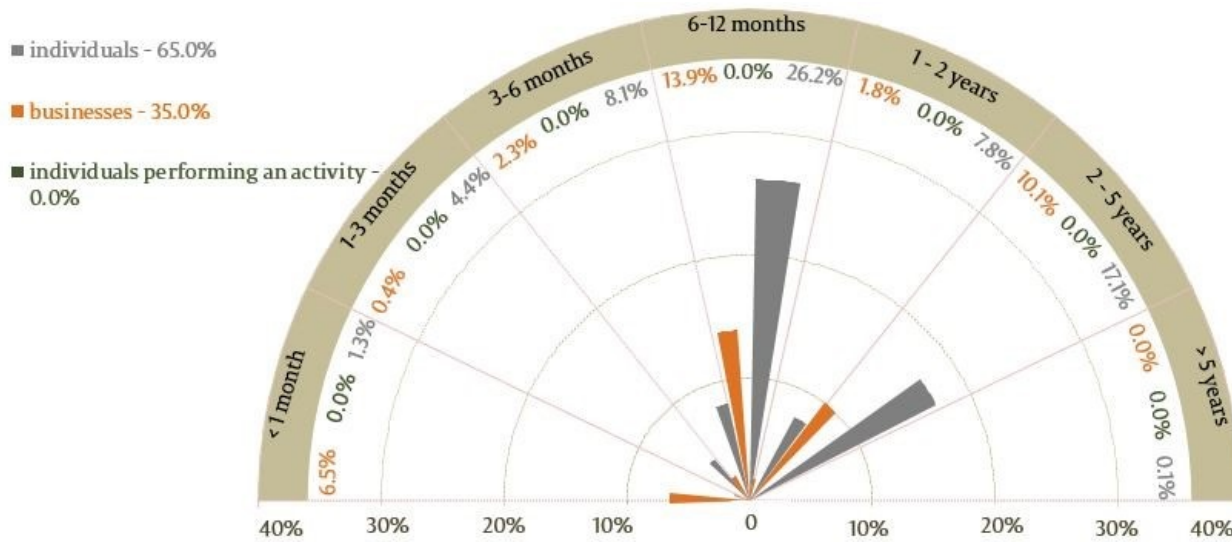
Domestic currency deposits totalled MDL 1,028.7 million (+40.5% compared to the previous month and -36.4% compared to May 2019).

Foreign currency deposits recalculated in MDL totalled MDL 587.7 million (+21.1% compared to the previous month and -40.4% compared to May 2019).

Domestic currency deposits accounted for a share of 63.6%, while foreign currency deposits -36.4%.

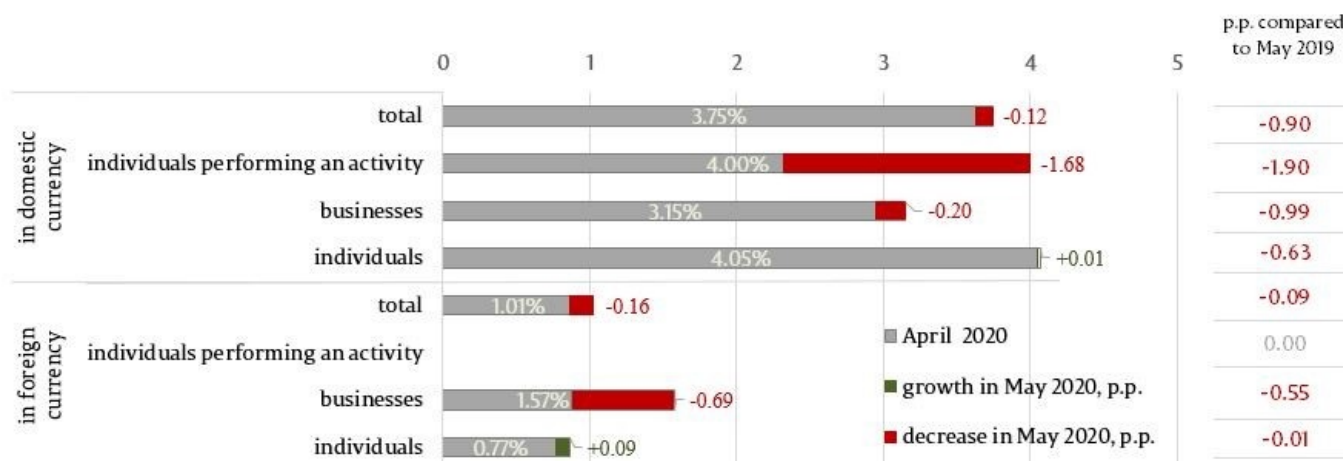
In May 2020, the largest share of deposits was represented by deposits of individuals – 65.0% (of which 38.6% represent domestic currency deposits, and 26.4% - foreign currency deposits).

In terms of maturity, the highest demand was recorded for deposits with terms from 6 to 12 months (40.1% of total term deposits). It is worth mentioning that by categories of clients, a significant share of deposits was held by individuals (26.2% of total deposits).

**The average interest rate of domestic currency term deposits constituted 3.63%, and of foreign currency – 0.86%.**

The average interest rate of new domestic currency term deposits decreased by 0.12 percentage points compared to the rates of the previous month. Individuals placed deposits at an average interest rate of 4.06%, legal entities – at an average rate of 2.95%, while individuals performing an activity – at an average interest rate of 2.32%.

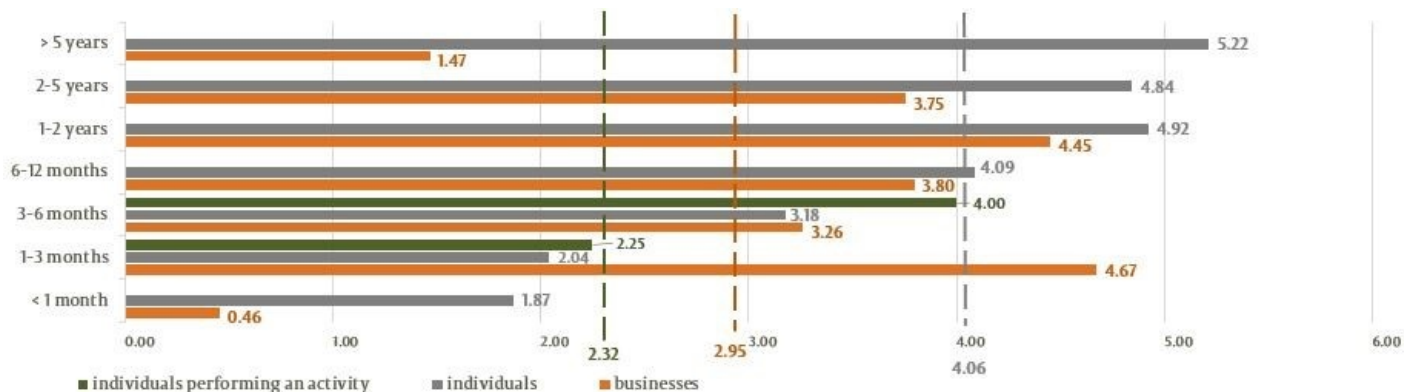
The average interest rate of new foreign currency term deposits decreased by 0.16 percentage points compared to April 2020. Individuals placed deposits at an average interest rate of 0.86%, legal entities – at an average rate of 0.88%, while individuals performing an activity did not place new deposits in foreign currency.

Compared to the similar period of the previous year, the average interest rates of domestic currency deposits decreased by

0.90 percentage points (deposits of individuals decreased by 0.63 percentage points, while for legal entities - by 0.99 percentage points, and for individuals performing an activity – by 1.90 percentage points). The average interest rate of foreign currency deposits decreased by 0.09 percentage points (deposits of individuals decreased by 0.01 percentage points, of legal entities decreased – by 0.55 percentage points, while individuals performing an activity- did not place foreign currency deposits during the reference period or in May 2019).

**Average interest rates of domestic currency deposits, by maturity, %**



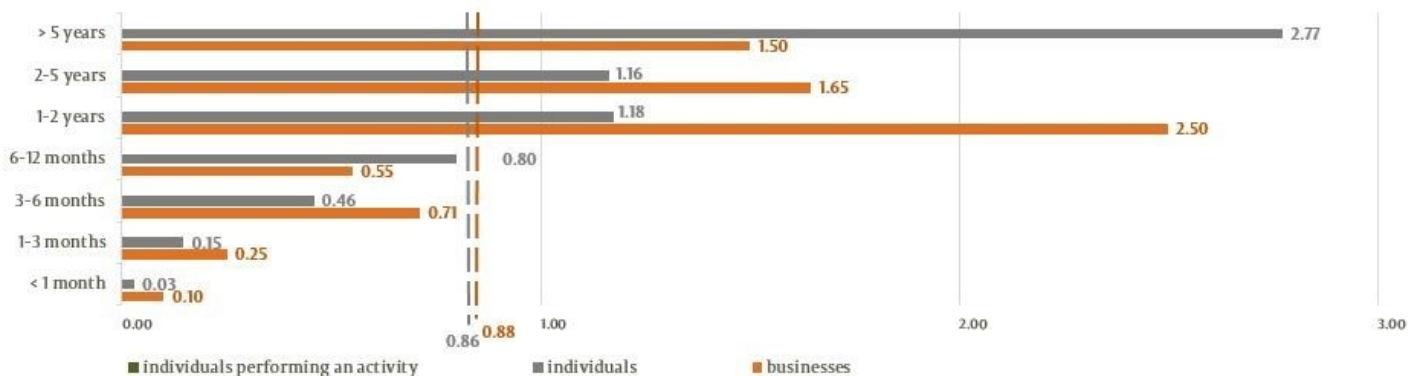

Domestic currency deposits with maturity from 6 to 12 months, which recorded the highest demand in the reporting period, were placed at an average interest rate of 4.00% (deposits for individuals – at a rate of 4.09%, for legal entities – at a rate 3.80%) (Chart 12). The most attractive foreign currency deposits, also, were recorded for the term deposits with maturity from 6 to 12 months were placed at an average interest rate of 0.69% (for individuals – at a rate of 0.80%, for legal entities – at a rate of 0.55%). The highest average interest rate of domestic currency deposits was recorded for the term deposits with maturity over 5 years for individuals – 5.22%. In the case of legal entities, the highest rate was registered in the deposits with maturity from 1 to 3 months (4.67%), while in the case of individuals performing an activity registered a rate of 4.00% for term deposits with maturity from 3 to 6 months. **Average interest rates of foreign currency deposits, by maturity, %**



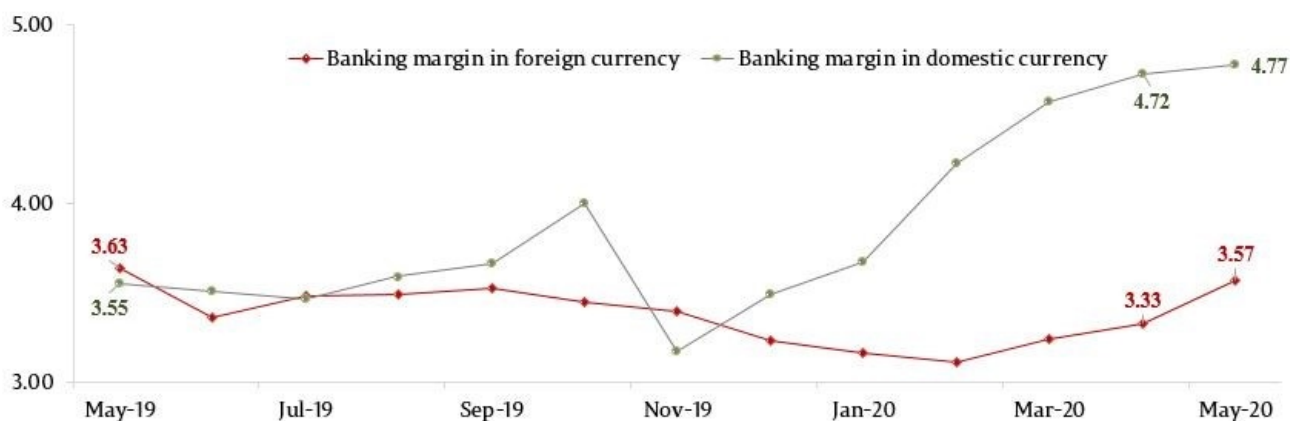

The highest average interest rate of foreign currency deposits was recorded for the deposits with maturity over 5 years for individuals (2.77%), legal entities, with maturity from 1 to 2 years (2.50%).

**Interest rate margin of domestic currency transactions constituted 4.77 percentage points, while of foreign currency – 3.57 percentage points.**

Interest rate margin of domestic currency transactions increased by 0.05 percentage points compared to the values of the previous month and by 1.22 percentage points compared to May 2019. (Chart 14)

Interest rate margin of foreign currency transactions increased by 0.24 percentage points compared to the previous month and decreased by 0.06 percentage points compared to May 2019.

The data of this report is presented according to the Guidelines on Preparation and Presentation of Reports on Interest Rates applied by banks in the Republic of Moldova, approved by Decision No 331 of 1 December 2016 of the Executive Board of the NBM, Official Monitor of the Republic of Moldova, No 441-451 of 16 December 2016, with further amendments and completions.

Loans foreign-currency-linked, according to the Regulation on the open currency position of the bank, approved by Decision of the Executive Board of the National Bank of Moldova No 126 of 28.11.1997, Official Monitor of the Republic of Moldova no. 112-114/198 of 14.10.1999, with further modifications and completions, refer to the assets which balance, according to the conditions established in the relevant contracts concluded by the bank, shall be modified depending on the evolution of the exchange rate of Moldovan currency against the attached exchange rate.

3. Individuals performing an activity, according to the Guidelines on the drafting by the licensed banks of the Report on monetary statistics, approved by Decision of the Executive Board of the NBM no. 255 of 17.11.2011, Official Monitor of the Republic of Moldova no. 206-215 of 02.12.2011, with further modifications and completions, work in associations without legal personality and are producers of goods and/or services for market, and namely, individual enterprises, farms, patent holders, notaries, lawyers, bailiffs, etc.”
