According to preliminary data, in Quarter I, 2023, the current account of the balance of payments recorded a deficit of US\$ 545,41 million, a 4,4% decrease as compared to the similar period of the previous year. The current account to GDP ratio amounted to -16,1%.

The capital account recorded a positive balance amounting to US\$ 16,74 million, and the financial account recorded a net inflow of US\$ 456,04 million.
