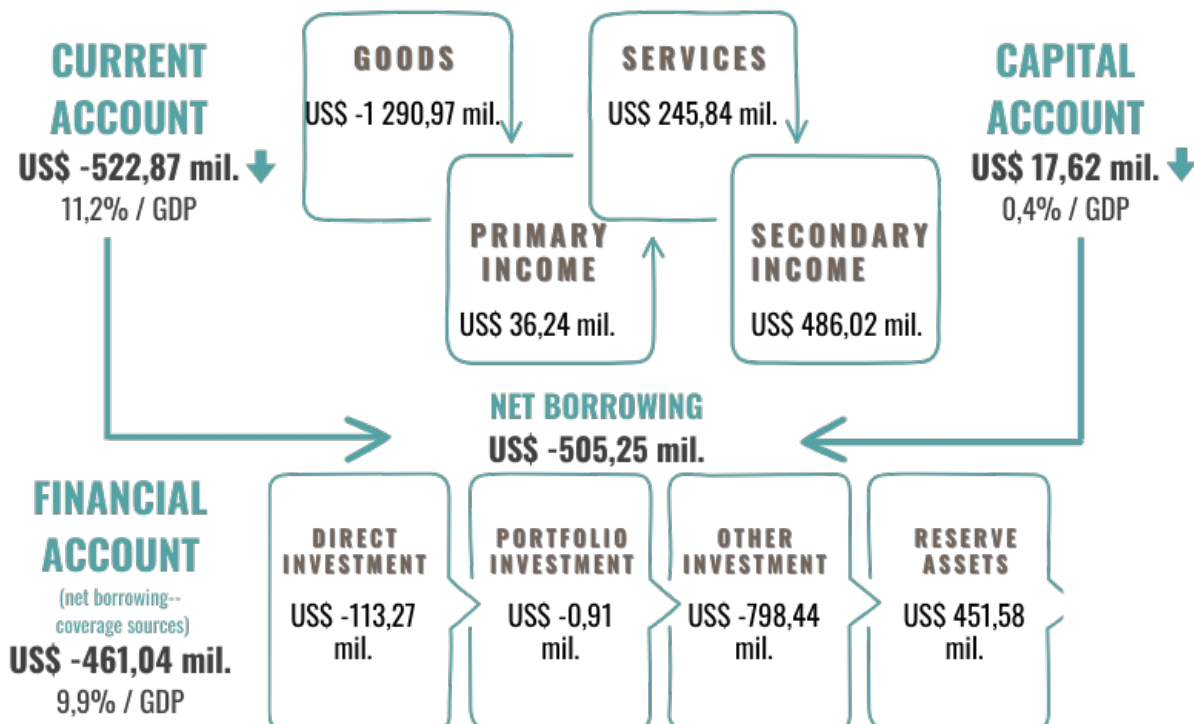

According to preliminary data, in Quarter IV, 2023, the **current account** of the balance of payments recorded a deficit of US\$ 522,87 million, a 36,3% improved as compared to the similar period of the previous year. The current account to GDP ratio amounted to -11,2%. The **capital account** recorded a positive balance amounting to US\$ 17,62 million, and the **financial account** recorded a net inflow of US\$ 461,04 million.
