

## Developments in LOANS market in May 2024

In May 2024, new loans extended<sup>1</sup> (Infographic 1) amounted to MDL 4,804.9 million, decreasing by 12.8% compared to April 2024. The largest share (77.8%) represents domestic currency loans, which totalled MDL 3,738.0 million, decreasing by 10.1% as compared to the previous month.

Infographic 1. Development in new extended loans<sup>2</sup>





In terms of maturity, loans with maturity ranging from 2 to 5 years recorded the highest demand, having a share of 57.0% in the total amount of extended loans. The share of these loans extended to businesses represented for 36.3% in the total amount of extended loans.

The average nominal interest rate on new domestic currency loans as compared to the previous month decreased by 0.01 percentage points to the value of 9.18%, while the average interest rate on foreign currency loans increased by 0.05 percentage points to the value of 6.09%.

In May 2024, individuals contracted new loans (Infographic 2) in total amount of MDL 1,583.0 million, decreasing by 8.4% as compared to the previous month, the largest share (67.5%) representing consumer loans. The largest part of these loans (MDL 936.4 million) was extended in domestic currency with a maturity ranging from 2 to 5 years.

A share of 32.0% of total loans extended to individuals represent to mortgage loans, which were mainly extended in domestic currency (99.8% of all mortgage loans).


The average interest rate on consumer loans extended in domestic currency increased by 0.05 percentage points to the value of 11.09%, while the average interest rate on loans granted in domestic currency to acquire real estate increased by 0.09 percentage points to the value of 7.71%.

Compared to the previous month, businesses requested less loans in domestic currency (-9.1%). The volume of loans in foreign currency decreased by 21.9%, while the volume of foreign-currency-linked loans<sup>4</sup> decreased by 20.5%.


Non-financial commercial companies contracted the largest share (60.9%) of new extended loans.

The average interest rate on domestic currency loans extended to businesses (Infographic 3) decreased by 0.02 percentage points, reaching 8.51%. At the same time, the average interest rate on foreign currency loans increased by 0.04 percentage points to the value of 6.08%.
