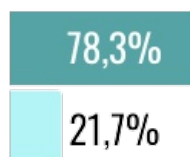
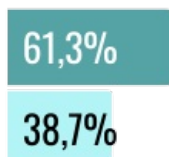

According to preliminary data, the net international investment position recorded US\$ -6 452,75 million as of 09/30/2023 (or -41,2% as a ratio to GDP), 4,3% more as compared to the end of 2022.
